



## BOOKING CONDITIONS:

- 1) The pitch or mobile home will be allocated by the Management, which does not give any right to complaints, waivers or claims for damages. However, it is the aim of the Management to assign a pitch in the requested area, according to seasonal availability. Camping tariffs are calculated according to the number of nights booked. If departure is **after 11:00 a.m.** this will be calculated as an additional day. **A non-refundable fee of €50.00 will be charged for the reservation of a specific numbered pitch or chalet for a minimum stay of 7 nights.**
- 2) In mid-season, high-season and high season plus, bookings will only be accepted for a stay of **3 nights minimum** for pitches with a minimum of 2 adults paying and **1 week** for the mobile homes. In the remaining months, the Management, at their discretion, may concede shorter stays. Likewise, in the months of July and August, the Management reserves the right, at the time of booking acceptance, to establish the maximum length of stay permitted for the pitches and mobile homes.
- 3) In the event of multiple bookings for small groups, the above rules remain valid for **each individual booking** and penalties or demands for deposits will therefore be calculated individually.
- 4) Upon final confirmation, a deposit will be requested, equivalent to 30% of the anticipated total sum payable, which will be deducted from the final bill. In certain periods of the year, (during special events, fairs, etc.), the Management reserves the right to request a deposit of 50%. For chalet bookings, payment of the balance is requested **no later than 2 weeks prior to the arrival date.**
- 5) Any bookings not confirmed by duly paying the deposit within **4 days from the request being sent**, will automatically be cancelled and the Management is in no way obliged to send any communication of such.
- 6) Payment of the deposit can be made by bank transfer to:

- 7) Payment may also be made via credit card. This method requires that you advise the Management, who will send an email with the banking link to which direct on-line payment can safely be made.
- 8) Should you need to cancel a booking, this must be communicated at least 30 days before the intended arrival date. In this event, the deposit paid will be reimbursed, minus a €50,00 fixed booking fee covering bank charges. Any cancellations that do not conform to the established deadline will **NOT** give the right to a refund of the pre-paid deposit. Likewise, in the event of 'no show,' the deposit will not be refunded.
- 9) The Campsite Management guarantees the availability of spaces booked **until 23:00 hours on the planned arrival date.** The entire period booked and confirmed is to be paid in full, likewise in the case of **late of arrival or early departure.** This also applies to any bookings made verbally at the time of arrival at the campsite reception.
- 10) From **23.00 to 07.00** hours silence is obligatory: it is forbidden to pitch or dismantle tents at these times and any form of noise that may disturb others must be avoided, furthermore it's forbidden the use of the car.
- 11) Visitors may enter the campsite on foot and will be required to deposit a personal document at reception. If the visit lasts for more than two hours, then a daily guest fee will be applicable. Visiting hours are from 08:30 to 20:00. Visitors are **NOT** allowed to make use of the facilities provided for campsite guests, unless the daily visitor's fee is paid.
- 12) Opening hours of the Reception office vary according to season. It is necessary to inform Reception of arrivals after 19:00 hours.
- 13) All bookings, including those made directly on our website [www.campingbrione.com](http://www.campingbrione.com), are subject to the **WRITTEN CONFIRMATION** of the Management.
- 14) At check-in, an identification bracelet will be provided, and it is obligatory to wear this at all times during your stay. Those found without the bracelet may be asked to leave.
- 15) Within the campsite **separated waste disposal is obligatory.** We kindly ask our guests to acquire the appropriate types of rubbish bags and to deposit them in the bins provided inside the campsite. We also request that guests respect the environment by limiting the usage of detergents and water consumption.
